## ***Teaching activity***

My teaching activity consists of the teachings of 'General Pedagogy 2' and 'Clinical Pedagogy' in the various Bachelor and Master Degree Courses activated by the Department (DISFOR) in which I teach and carry out my research activity. In the academic year 20017-2018, I taught 24 CFU in the course. This didactical activity includes weekly student receptions, reports and correlations of Degree Theses, tutor functions for students' internships. To this are added the didactical activities connected with the development of seminars (in this regard, I was, from the academic year 2001-2002 until 2016-2017, scientific-didactical director of the Permanent Seminary of General Pedagogy) and the coordinator of research groups that also involve students.

## ***Research interests***

My scientific research moves, in particular, in the following thematic areas: a) General Pedagogy, understood as a general science of the self-formation, education and instruction of human being; b) the History of Pedagogy, investigated in the light of the theory of history and the philosophies of formation that distinguish it; c) Pedagogical Epistemology, interpreted as a critical reflection aimed at the rigor of the pedagogical discourse; d) Clinical Pedagogy, considered as a pedagogical, specific and sectoral science, aimed at the study of human being's 'deformation' and 'diseducation', as well as the elaboration of the pedagogical-clinical intervention; e) the Pedagogical Sciences, the Educational Sciences and the Formation Sciences, interpreted as scientific fields having, with the General Pedagogy and the History of Pedagogy, relationships of an intradisciplinary, interdisciplinary and transdisciplinary nature; f) the scientific-epistemological synergy between General Pedagogy, History of Pedagogy, Philosophy of Education and Philosophy of Education; g) the Italian epistemological debate from the late Twentieth century to the first decades of the Twenty-first century; h) the concept of 'education' and 'self-formation' in the United States of America i) the categories of 'deformation' and 'miseducation' in the American scientific-cultural panorama; l) philological and etymological research in pedagogy and history of pedagogy; m) the concept of 'classic' in pedagogy;

n) the dialogue between Geisteswissenschaften and Naturwissenschaften; o) the relationship between clinical, genetic and epigenetic pedagogy; p) the problem of originality in the formation of human being and in the categories of historical-pedagogical matrix; q) questions of logic, language and method in pedagogy; r) classical German philosophy and its contribution to the theories of formation and education, cultured in their historical development; s) general pedagogy and the history of pedagogy in relation to the philosophies of education and formation.
