

Short bio

Enrico Albanesi (PhD) is an **Associate Professor of Constitutional Law at the Department of Law, University of Genoa**, where he holds a course in Constitutional Law (1st-year students), a course in Constitutional Law (5th-year students) and a course in Legislative Drafting.

He is also an **Associate Research Fellow at the Institute of Advanced Legal Studies (IALS), University of London**, where he co-leads the IALS Law Reform Project.

He wrote a monograph on the Constitutional Court and the advisory opinion under Protocol No. 16 to the ECHR (2021); a textbook on legislative drafting for University students (2019-2nd edition); a monograph on constitutional pluralism and EU infringement proceedings (2018); a monograph on committee reports (2010).

He also co-wrote a textbook on media law (2025-13th edition).

He had been working for several years as legal advisor to the President of the *Comitato per la legislazione*, the committee of the Italian Chamber of deputies that scrutinises the quality of bills.

He has been Adjunct Professor of Contemporary Constitutional Law at the *Institut d'études politiques de Paris (Sciences Po)*, Menton Campus (France); Guest Lecturer at the University of Warsaw (Poland), University of Tartu (Estonia), University of Turku (Finland) and University of Akureyri (Iceland); Visiting Professor in the Erasmus+ Joint Master in Parliamentary Procedures and Legislative Drafting (EUPADRA) at the Universidad Complutense in Madrid and at the IALS; Visiting Scholar at the College of Europe in Bruges (Belgium); Visiting Research Fellow at the IALS.

He has given several presentations overseas (Albania, Algeria, Belgium, Bulgaria, Chile, Estonia, Finland, France, Georgia, Hungary, Iceland, Indonesia, Israel, Japan, Montenegro, Poland, Portugal, Romania, Serbia, Spain, Sri Lanka, Tajikistan, Thailand, Uganda, Ukraine, United Kingdom, United States, Vietnam) and published articles in peer-reviewed international books and journals, such as *European Journal of Law Reform*, *The Theory and Practice of Legislation*, *Statute Law Review*, *The Cardozo Electronic Law Bulletin*, *European Public Law* and *International Journal of Parliamentary Studies*.

From 2023 and 2025 he was four times in Ukraine, where he gave lectures in several Ukrainian Universities (Uzhhorod, Chernivtsi, Kyiv, L'viv, Odesa, Kharkiv).

In February 2024 and April 2025 he gave lessons in Kyiv to the Research Service of the Ukrainian Parliament (*Verkhovna Rada*) on legislative drafting.

In June 2023 he was heard in Kyiv (Ukraine) by the Constitutional Court of Ukraine about the constitutional and legislative reform required to Ukraine by the Venice Commission and the European Commission.

In 2024 he was the Principal Investigator (for the University of Genova) within the Research Project *SUPER – Supporting Ukraine’s Progress on EU reforms* (European University Institute (EUI) Widening Europe Programme initiative). In 2026 he was within the team of the Research Project *PROMPT – PROMoting Media Pluralism and Transparency in Ukraine* (European University Institute (EUI) Widening Europe Programme initiative).

In July 2025 he took part in the *Ukraine Recovery Conference 2025* in Rome.

In July 2023 he was heard remotely by the Chilean *Consejo Constitucional – Comisión de Función Jurisdiccional y Órganos Autónomos* about the project of a new Constitution of Chile. In 2016 he was heard by a delegation of the French *Conseil d’État*, visiting Italy, about codification and the quality of legislation in Italy.

In October 2023 he gave a presentation within the seminar on *Judicial Dialogue through the Advisory Opinion Mechanism under Protocol No. 16* at the European Court of Human Rights in Strasbourg (France).

In May 2024 he gave oral evidence before the *Comitato per la legislazione* of the Italian *Camera dei deputati* and of the Italian Senate on the quality of legislation.

In 2025 he was appointed by the Institute of European Media Law (EMR) to write the country report on media services in Italy; by the European Commission to work on a report on defamation law in Albania; and by the Council of Europe to work on a background study on media pluralism in the online environment.
