

VINCENZO SCIARABBA

Associate Professor of Constitutional Law

EDUCATION AND TRAINING

Born in 1979 in Pavia, where he attended classic high school. In 1995 he won a competition on contemporary history and European integration and a stage at the European Parliament and the ECtHR.

He graduated in Law (historical-comparative course) in Pavia in 2003, with 110/110 cum laude, discussing a degree thesis on *"The Charter of Fundamental Rights of the European Union"*.

Between 1998 and 1999 he also attended – with grant – the University School for Advanced Study (IUSS) in Pavia. Between 1999 and 2001 he was tutor of Private Law course and students' delegate at Faculty Committee and Didactic Commission. In 2002 he took part in "Forum on international justice and human rights" in Pavia.

In January 2007 PhD degree in Constitutional Law – thesis on *"Fundamental Rights and Principles among National and European Sources and Courts: Events and Prospects of National Constitutional system, of EU and ECHR"* (evaluation: excellent) – at University of Milano, where he collaborated with the chairs of *Comparative Public Law* of professors Floridia and Iacometti, of *English and American Law* of professor Bognetti and *Constitutional Justice* of professor Onida. Between 2004 and 2006 he also attended professor Carrozza's course "Human rights" and a seminar cycle "The Comparative Constitutional Justice" held by professor P. Pasquino joined to professor Onida's course "Constitutional Justice".

PROFESSIONAL HISTORY

After obtaining his PhD at University of Milano, he served as research fellow in *Comparative Public Law* at the University of Pavia (2007-2010)

Then he served as temporary researcher in the same field at the same University (2010-2013).

For five years (2009-2014), he also served as scientific and educational coordinator of the Advanced School for Legal Professions Pavia-Bocconi (www.lawschool.it).

For about 2 years (2014-2016) he served as Accredited Parliamentary Assistant at the European Parliament, mainly dealing with legislative work and legal and political issues within the remit of the *Committee on Civil Liberties, Justice and Home Affairs,* inter-institutional negotiations and other various issues related to the task and the institutional context.

Since 2019, he is Associate Professor of Constitutional Law at the University of Genova, where he has also taught or teaches *Rights of Liberty and Social Rights*, as well as - also in English - Comparative Public Law; and, in English, Global Consitutionalism.
