Research interests

My early research work involved an investigation of the phenomenon of reception and translation of German Pandectist science in Italy between the 19th and 20th centuries, especially by analysing the Italian versions of Pandectist works. Above all, she examined C. Fadda and P.E. Bensa's version of Windscheid's *Lehrbuch des Pandektenrechts*, which became famous especially thanks to the notes written by the Italian translators to give a commentary on the German original text. Therefore, I paid specific attention to the original features of the Italian approach to the new teaching and researching methods, which paved the way to the following development of an Italian science of private law, embodied by Fadda and Bensa's notes. The main results of this study are explained in a monography published in 2016, as well as in papers published in scientific journals and volumes in Italian, English and German.

More recently, I have focused on the different drafts of complete and independent maritime codes, which were elaborated within the Italian Mediterranean area by the end of the 18th century. I have reconstructed especially the features of the Habsburg project (*Progetto del Codice per l'Austriaca Mercantile Marina*, 1785), by comparing it to the other contemporary drafts for the Kingdom of Naples (1781), the Republic of Venice (1786) and the Kingdom of Sardinia (1791) and paying particular attention to the insurance regulations. I am now continuing the research on this topic. Furthermore, I have studied Italian criminal science between the 19th and 20th century and the introduction of Italian Criminal Code «Zanardelli» and Criminal Procedure Code «Finocchiaro-Aprile» in the territories annexed by the Kingdom of Italy in 1918 (the so-called *Nuove Province*). I have analysed especially the contribution by V. Mazini and S. Longhi, who held in Trieste an extraordinary course of Criminal Law and Procedure in 1920 to describe the fundamentals of Italian criminal codes to local lawyers and judges. The first results of these researches have already been incorporated into articles published in national A-range journals.

In the context of the international research project "A Comparative History of Insurance Law in Europe (CHILE)", funded by European Research Council – ERC (Scientific Director Prof. Dr. Phillip Hellwege, University of Augsburg) I participated in the scientific conference "The Risk of Fire" (Augsburg, 12-14.09.2019) as lecturer, by examining the development of fire insurance and its regulation in the Italian area, before and after the national unification. The results of this work are published in an international scientific volume in English (Duncker & Humblot, Berlin, 2021).
