Research interests

I am an empirical economist working on applied economics issues: in particular, my interests span the fields of industrial economics, transport economics and labour economics. In the case of industrial economics, I have done work on optimal industry configuration (e.g. measurement of economies of scale and scope) in regulated public utilities such as water and airports; moreover, I have been studying the role played by regulation and competition on firms performance and pricing. In the case of transport economcis my research has dealt with the impact of transport infrastructures (roads, ports and public infrastructures in general) on

economic activity. Finally, I have recently analysed the role played by labour market institutions -such as employment protection legislation and unions- on the evolution of firm and industry's investment in physical and human capital, productivity, allocative efficiency as well as firm dynamics.

Assignments abroad

Between 2016 and 2018 I have been Senior Researcher at the Joint Research Centre of the European Commission, where I have worked on the econometric ex post impact assessment of various EU regulations.
