

Concise CURRICULUM of Prof. Lawyer MAURO CHIRCO born in Genoa on Oct. 31st, 1948.

Degree in Jurisprudence in 1972 with thesis in Maritime Right at the University of Genoa, after achieving a specialized scholarship "ad hoc" to be used in London.

Entrusted with exercises from 1972 to 1974 at the teaching of Law and Technique of maritime insurance of the Faculty of Economy and Commerce at the University of Genoa.

Regular teacher from Oct. 9th, 1974 to July 31st, 1980 of a five years contract, then postponed at the Institute Poliprofessorship of Naval Engineering of the University of Genoa for the course of "Juridical Subjects (Shipping law)". Researcher, at the above mentioned Institute with juridical beginning from August 1st, 1980, while from June 11th, 1993, he was moved, on request, as a confirmed searcher of Maritime law at the Faculty of Economy at the University of Genoa and particularly at the Department of the of Economy and Enterprise law dealing with maritime insurances.

He has taught seminars of maritime law in Italy and at the University of Italian Switzerland (Lugano).

He has also been, till the pension, Dec 31st, 2010, Aggregate Professor for the teaching of "Shipbuilding law ("disciplinary sector" Law of Navigation), in the above mentioned Faculty - now Department - (Degree in ECONOMY AND MARITIME AND PORTUAL MANAGEMENT). After the retirement he has obtained a special paid contract from 2011 to 2014 to continue to teach the same subject in the Department of Economy. As to this subject he offered to students duplicated lecture notes – continuously updated on civil and public shipbuilding law. From the end of 2014 on he has been entrusted by the Department of Economy to teach a new subject and in particular "Law and practice of National, Eu and International shipping programmes". He has been speaker in many Conventions of Maritime law and particularly in this last period he has organized at his Faculty/Department, on May 28th, 2010, the Convention "The building of the ship": multidisciplinary vision, reality and perspectives" and he was a speaker too.; he has also been among the speakers, in particular on the contract of sale of ships and shipbuilding, while on May 13th, 2011, he organized at the Faculty of engineering the Congress "Economic crisis": offered solutions in the insurance, juridical and financial fields for the sector of shipbuilding". Report to the Convention "ILO MARITIME LABOUR CONVENTION 2006" June 20th, 2012 on the subject "REFLECTIONS OF THE CONVENTION ON THE P&I COVERS". He has, moreover, developed (contract dated June 17th, 2012) an activity of support to the search for the Interuniversity Centre of Research Transport in the ambit of the project CUSTOMS MED - program of territorial cooperation ENPI CBC with a request of analysis of the juridical contest - customs normative and of the customs procedures in the international, EU and national fields with particular reference to the organization and to the procedures also data processing, in the port of Genoa.

He was a Cassation Lawyer enlisted in the List of Genoa Bar Association since 1976 until 30/12/24 specialized in Shipping and Transport law. In such field he has dealt with problems of maritime and multimodal transports, of expeditions by sea, of forwarding agents shipbrokers and shipowners, of customs forwarding agents, of contracts and relations relative to sale of ships and shipbuilding, accidents on the sea, safety and security, sea insurances and P&I, sea contracts, maritime labour and so on. Recently because of the previous experiences relative to Mexico and Nigeria, for a ship owner and maritime carrier, connected with intermodal company, he has followed all juridical parts of the constitution and development of a line of intermodal transports (trailers and ferryboats ro-ro pax) between Egypt (before also Syria) and Europe in/out, also dealing also with the relative interconnections legal/customs and navigation safety. He has faced similar problems in Brazil with a visit there in May 2012, ended on May 25th, 2012; considering contacts for shipping interuniversity projects with local Universities (Santos Catholic University and the Universidade Federal de Sao Paulo) and of projects for shipyards and shipping lines. Very good knowledge of spoken and written English and good knowledge of French.
