The implementation of language skills covers, also, other languages used in the European Union, which use is, nowadays, necessary to work in our integrated European system. The course offers the students the possibility to reach the knowledge needed for those who wish to pursue an even more advanced level of studies by teaching the various branches of law and a competitive study and research method. The final dissertation, about 320 pages, wanted to offer a substantial proof to the public opinion and the scientific community about the conditions of the people under investigation. Meaning that, even today, people under investigation are more likely an object of the criminal procedure, rather than a part with rights and dignity. The study of the provisions and jurisprudence concerning interrogation in incommunicado and pre trial detention was mainly focused on the United States and German system with special attention, for the latter, to the European Court of Human Rights' jurisprudence which, at least theoretically, should actively defend human rights, especially in such times like the one we are living in when police is tempted to forget his boundaries under the feeling to prevent any form crime. (Title of the dissertation: <i>Interrogation and Pre-Trial Detention: Principles and Effective Protection in the German and North American System</i>).
